# THE BUILDING REGULATIONS

## NOTES FOR GUIDANCE - DEPOSIT OF FULL PLANS

---

- 1 The applicant is the person on whose behalf the work is being carried out, eg the owner of the building.
  - 2 Two copies of this notice should be completed and submitted with plans and particulars in duplicate in accordance with the provisions of the Building Regulation 13.  
  
Subject to certain exceptions where Part B (Fire Safety) imposes a requirement in relation to proposed work, two further copies of marked up Fire plans which demonstrate compliance with the requirements should be deposited.
  - 3 Subject to certain exceptions a Full Plans Submission attracts fees payable by the person by whom or on whose behalf the work is to be carried out. Fees are payable in two stages. The first fee must accompany the deposit of plans and the second fee is payable after the first site inspection of work in progress. This second fee is a single payment in respect of each individual building, to cover all site visits and consultations which may be necessary until the work is satisfactorily completed.  
  
The appropriate fee is dependent upon the type of work proposed. Fee scales and methods of calculation are set out in the Guidance Notes on Charges which are enclosed. Cheques should be made payable to North Yorkshire Building Control.
  - 4 Subject to certain provisions of the Public Health Act 1936 owners and occupiers of premises are entitled to have their private foul and surface water drains and sewers connected to the public sewers, where available. Special arrangements apply to trade effluent discharge. Persons wishing to make such connections must give not less than 21 days notice to the appropriate authority.
  - 5 If your proposal involves the installation of a septic tank, consent for the discharge will be required from the Environment Agency, Coverdale House, Aviator Court, Clifton Moor, York YO3 4UZ. Telephone: 0870 8506506
  - 6 Where it is proposed to erect the building or extension over a sewer or drain shown on the relative map of public sewers, you will be expected to obtain written approval from Yorkshire Water Waste Water - Sewerage Development Team, Blackburn Meadows WWTW, Alsing Road, Sheffield, S9 1HX. Telephone: 0114 251 8257
  - 7 LABC Services provides a Partner Authority Scheme and also National Type Approval for a range of building types, building systems and major building elements where they are used repeatedly. If this proposal is to use the Partnering scheme please answer YES and provide further details, including name of the Partner Authority, in section 8. If the work proposed or any part of it is subject to a LANTAC approval please answer YES and enclose a copy of the appropriate current certificate(s). If there is any variation in this proposal from that shown on the LANTAC type approval plans attention should be drawn to it in a covering letter.   - 8 The Regulatory Reform (Fire Safety) Order 2005 applies to all premises that are 'workplaces' and imposes a duty on the responsible person to comply with its requirements.  
  
Workplace includes any premises or parts of premises, not being domestic premises, used for the purposes of an employer's undertaking and which are made available to an employee as a place of work.
  - 9 Section 16 of the Building Act 1984 provides for the passing of plans subject to conditions. The conditions may specify modifications to the deposited plans and/or that further plans shall be deposited.
  - 10 A completion certificate will be issued following a satisfactory completion inspection. This is subject to the local authority being notified of all necessary inspections.
  - 11 Persons proposing to carry out building work or make a material change of use of a building are reminded that permission may be required under the Town & Country Planning Acts. You are advised to consult the Area Planning Officer if you are in any doubt.
