Some examples of fraudulent claims are:

- claiming benefit when you are not living or paying rent at the property concerned;
- claiming benefit while you are working without telling us how much you earn; and
- claiming benefit as a single person while you are living as a couple.

We have set up a fraud hotline and we strongly encourage members of the public to ring us to tell us about anyone they think is claiming benefits they are not entitled to. **You do not need to give your name.** We will look into all the information we receive and take firm action against people who are abusing the system.

As well as our main council offices at Ryedale House, we also have three area offices where you can hand in your filled-in application form, and we can photocopy original documents as proof.

Evidence of earnings

Notes for filling in the Housing Benefit and Council Tax Benefit claim form

About this form

The Housing Benefit and Council Tax Benefit claim form has been specially designed to be easy to fill in. It may look rather long, but we have to ask a lot of questions to make sure that everyone who claims gets the right amount of benefit.

You may not have to fill in all parts of the form, but you must fill in any part that is relevant to you. Every part starts with a question to help you decide if you need to fill in that part.

Second Adult Rebate

Second Adult Rebate is Council Tax Benefit for people who may not have a partner but who share their home with someone who:

- is 18 or over;
- is on a low income; and
- does not pay them rent.

If you are claiming Second Adult Rebate, only fill in Part 1, Part 3 and Part 15 of this form.

Evidence

We need to see evidence of some of the things you tell us about. There is a checklist at the end of the form to help you. If you are not sure if we need to see evidence of something, get in touch with us.

We will tell you what we need to see. We cannot pay you benefit until we have seen the evidence we have asked for.

Filling in the form

If you are filling in this form by hand, use black ink. Do not use pencil. If you make a mistake, just cross it out and put the right answer next to it. Do not use correction fluid or tape.

Answer 'Yes' or 'No' questions by putting a tick in the relevant box. If you are picking an answer from a list of answers, put a tick in the relevant box. Do not put a cross in any boxes. If you answer a question with a cross we will have to send the form back, and this will delay the claim.

Or you can get in touch with an organisation like the Citizens' Advice Bureau. The address and phone number of your nearest bureau is in The Phone Book.

What to do next

When you have filled in the form, sign it and send it to us, with the evidence we need to see. Or you can bring the form and evidence to us. Do not send valuable items such as benefit order books, bankbooks or passports in the post. Bring them to our reception and we will get the information we need and give them back to you.

If you cannot get the evidence we need straightaway, do not worry. Send the form to us, but let us know that you will be sending some evidence later. If you do not send the form to us straightaway, you might lose money. If you cannot get the evidence within 2 or 3 weeks, let us know. We may be able to help you.

When we usually pay benefit from

If this is your first claim: We will usually pay your benefit from the Monday after we get your form.

If this is a repeat claim: If we get your form within 4 weeks of when your last claim finished, we will pay your benefit from the day after the last claim ended. If the form arrives more than 4 weeks after your last claim finished, we will usually only be able to pay your benefit from the Monday after we get your form.

Changes you must tell us about

If you receive benefit or have applied for benefit you must tell us about changes in your circumstances.

You must tell us immediately and in writing even if you have already told another section within the council.

If the change would increase your benefit and you do not tell us straight away you may lose benefit. If the change would decrease your benefit and you do not tell us straight away you may have to repay an overpayment of benefit.

Please tell us the date or dates of the change and send documents as evidence of the amounts and dates.

There are different rules for different people:

1. If you receive Guarantee Pension Credit:

You must tell the Pensions Service about all changes other than those shown below which you must tell the council about.

You must tell the Council about:

- any changes to your tenancy (such as, rent increase)
- any changes to non-dependants income or if they move in or out
- any time away from home likely to be more than 13 weeks

2. If you receive Savings Pension Credit but not Guarantee Pension Credit:

You must tell the Pensions Service about all changes other than those shown below which you must tell the council about.

You must tell the Council about:

- any changes to your tenancy (such as, rent increase)
- any changes to non-dependants income or if they move in or out
- any time away from home likely to be more than 13 weeks
- any change to dependant children
- anyone coming to live in or leaving the household
- any change to Child Tax Credit
- any change to Child Benefit
- any change to your total savings, investments or capital, especially if they now add up to more than £16,000
- any changes to the income and capital of your partner if they are not included in your Savings Pension Credit claim

3. All other Customers

You must tell the council about all changes that may affect you benefit.

Some examples of the things you must tell us about are;

- any change to your tenancy (such as, rent increase)
- end of Income support or Job Seekers Allowance
- starting work
- any increases in your wages or earnings
- any change to your total savings, investments or capital, especially if they now add up to more than £16,000
- any change of address (you will need to re-apply for benefit at your new address)
- any time spent in hospital
- any awards or changes in any state benefit
- any changes in maintenance payments from a former partner
- anyone coming to live in or leaving the household
- any changes in the income of a household member
- any time away from home likely to be more than 13 weeks

This is not a complete list, if in any doubt about a change in circumstance please contact the Benefits office.

You must tell us about these changes in writing – a phone call is not enough.

If you don't tell us about these changes you may lose money you are entitled to or you may get too much benefit.

You must make sure that you tell us about these changes. Don't rely on someone else to pass the message on.

It is an offence not to tell us about any change of circumstance that affects your benefit. We may take court action against you and if we pay you too much benefit, you will probably have to pay it back.

How we collect and use information

We will use the information you give in this form, and in any supporting evidence you send us, to process your claim for Housing Benefit and Council Tax Benefit.

We may pass the information to other agencies or organisations such as the Department for Work and Pensions and the Inland Revenue, as allowed by law.

We may check information you have provided, or information about you that someone else has provided, with other information held by us. We may also get information about you from certain third parties, or give them information to:

- make sure the information is accurate;
- prevent or detect crime; and
- protect public funds.

These third parties include government departments, local authorities and private-sector companies such as banks and organisations that may lend you money.

We will not give information about you to anyone else, or use information about you for other purposes, unless the law allows us to.

We, **Ryedale District Council**, are the data controller for the purposes of the Data Protection Act. If you want to know more about what information we have about you, or the way we use that information, please ask us.
