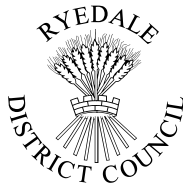

**Second Adult Rebate guidance notes (Please read these carefully.)**

The full Council Tax bill assumes that there are two or more adults living in a property. For Council Tax purposes, we may disregard (ignore) certain people when we work out the amount of benefit. If there are two or more adults living in the property, Second Adult Rebate may apply if they are:

- not liable to pay you rent;
- not your husband or wife or civil partner or partner;
- not liable to pay Council Tax at this property; and
- on a low income or receiving Income Support.

**1 What is Second Adult Rebate?**

This is an alternative benefit that covers up to 25% of the full Council Tax bill.

**2 Who may apply?**

The person who has to pay Council Tax can apply. Second Adult Rebate can only be given to the person who pays Council Tax. The rebate is based on the circumstances of each adult living in the property.

**3 Is Second Adult Rebate restricted to certain types of people?**

The regulations restrict the amount of Second Adult Rebate that can be given to people who are:

- over 18;
- not paying the rent; and
- not receiving Child Benefit.

**4 When is Second Adult Rebate not paid?**

Second Adult Rebate is not paid:

- for the liable person;
- if the person is a joint owner or tenant;
- if the person is disregarded for Council Tax purposes;
- if the person is living in the property as part of a business arrangement; or
- if the combined gross weekly income of all 'second adults' is more than £228

**5 What is a disregarded person?**

We ignore a disregarded person when we assess Council Tax Benefit. The main groups of people we disregard are shown on the application form.

**6 How much Second Adult Rebate can I get?**

You can get up to 25% off your Council Tax or 100% if you are the householder and a full-time student, depending on the circumstances of the other adults.

<b>Circumstances</b> (income levels as from 1 April 2009)	<b>Amount of reduction</b>
Second adults who receive Income Support or Jobseekers Allowance (income based) ESA (IR) or Pension Credit with a full-time student householder.	100%
Second adults who receive Income Support or Jobseekers Allowance (income based) ESA (IR) or Pension Credit.	25%
Gross income of second adults is less than £174.99.	15%
Gross income of second adults is between £175 and £227.99 a week.	7.5%
Gross income of second adults is more than £228 a week.	0%

**7 If I am already claiming Council Tax Benefit (or have applied) can I still apply for Second Adult Rebate?**

Yes, you can still apply for Second Adult Rebate. We will compare your main Council Tax Benefit entitlement to 25% of your Council Tax liability. If your entitlement is less than or the same as 25% of your Council Tax liability, we will grant the higher of the main Council Tax Benefit or Second Adult Rebate.

**8 Do you ignore any income when you work out my benefit?**

Yes, we ignore Attendance Allowance or Disability Allowance, if the second adult is receiving Income Support, Jobseekers Allowance (income based) Employment Support Allowance (Income Related) and Guaranteed Pension Credit and/or Savings Credit and any income a disregarded second adult earns.

**9 How do I apply for Second Adult Rebate?**

Simply fill in the enclosed form and return it to Benefits Services as quickly as possible.

**10 If I am eligible, how will I receive Second Adult Rebate?**

We will take any entitlement from your Council Tax account. We will tell you if you are or are not entitled to Second Adult Rebate.
